Importance of presenting the need and innovation of the project in a well-founded manner

- The proposal appropriately discusses the background and the rationale of the project, with good support of the timeliness and relevance of the specific thematic area.
- It also very well discusses the overall aims and the specific objectives of the project, clearly demonstrating their relevance in relation to the Erasmus Mundus Design Measures.
- There is good elaboration and clear evidence that the project would contribute to the objectives of the Call



Importance of naming certain future partners at the time of submission

- The demand for the planned joint Master programme is well-substantiated, and the need for an international approach represented by the partners is justified
- The proposal explains in detail the good partners' strategy to prepare the envisaged Master programme.
 - The proposal very clearly demonstrates that this project appropriately builds on the results and acquired experience of past and current courses and activities carried out **by the partner institutions** in the targeted field.



Importance of obtaining a certain amount of commitment from the future partners beforehand

- The outlines of the Master programme confirm that the **partners have a clear concept** of the programme to be designed.

Importance of advanced investigation of the European Approach for Quality Assurance
